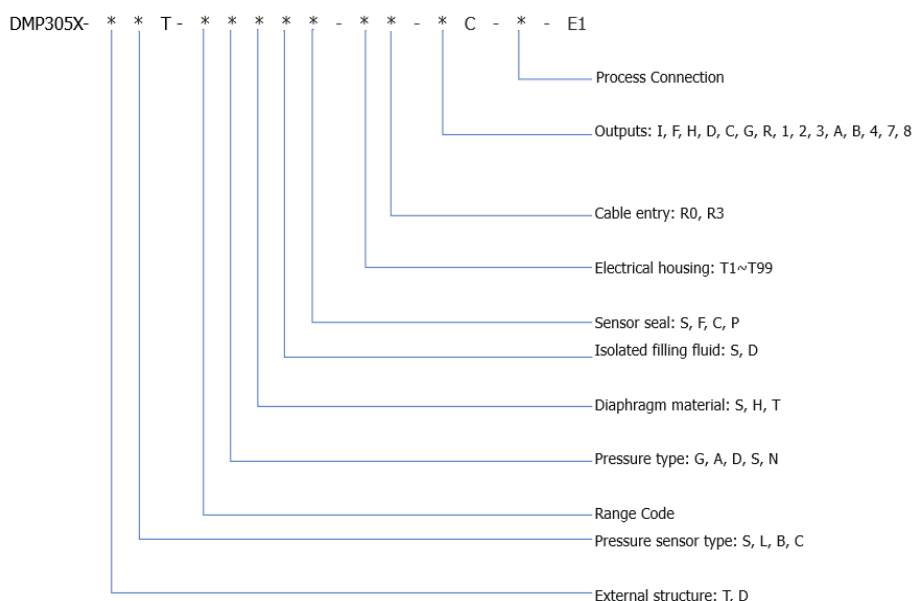

13 DESCRIPTION OF EQUIPMENT

DMP305X gauge/differential pressure transmitter adopts casting moulding aluminum alloy housing, the interior of the housing is a single chamber design. Between front cover, rear cover, explosion-proof plug, and housing, there are threaded flameproof joints. And it adopts O-ring and gasket sealing to approach IP66. The cement joint between display window and head cover applies sealing adhesive and fixed by a clamping ring. The adhesive length is greater than 10mm.

DMP305X gauge/differential pressure transmitter outputs a current signal suitable for the industry-standard by receiving the sensor's electrical signal and correction coefficient. The transmitter is designed to be flameproof and dustproof.
